TERMS AND CONDITIONS

1. INTRODUCTION

- 1.1. By registering and participating in The Entertainment Grounds Virtual Punters Challenge participants agree to be bound by these official rules.
- 1.2. The Entertainment Grounds Virtual Punters Challenge, which runs on the 14th March 2020, eligible participants are able to create one user registration.
- 1.3. There are no fees, charges or purchases required to play The Entertainment Grounds Virtual Punters Challenge 14th March 2020 other than relevant internet usage costs and racecourse entry fees.

2. TERMS OF GAME

- 2.1. The Entertainment Grounds Virtual Punters Challenge opens at 12:01pm Australian Eastern Standard Time on Saturday 14 March 2020 and closes at 6:12pm AEST on Saturday 14 March 2020.
- 2.2. The Entertainment Grounds Virtual Punters Challenge is open to all people 18 years and over, known as participants.
- 2.3. To win The Entertainment Grounds Virtual Punters Challenge prizes, you must qualify as an eligible participant.

3. ELIGIBLE PARTICIPANTS

- 3.1. In order to be an eligible participant, you must be 18 years or older and provide your first name, last name, mobile number, email address and agree to the terms and conditions.
- 3.2. Directors, officers and employees of The Entertainment Grounds and The Great Tipoff are ineligible to participate in The Entertainment Grounds Virtual Punters Challenge and the same exclusion applies to their immediate families. For the purposes of these terms and conditions, immediate families meaning spouses (including de-factos), parents, siblings, children, grandparents, grandchildren, parents in law, step-parents, step-children and half-siblings. None of these persons can be an eligible participant.

4. HOW TO PARTICIPATE

- 4.1. To participate, eligible participants must, during the promotion period:

- 4.1.2. Register for The Entertainment Grounds Virtual Punters Challenge using the online registration form;
- 4.1.3. Join The Entertainment Grounds Virtual Punters Challenge competition;
- 4.1.4. participate in The Entertainment Grounds Virtual Punters Challenge in accordance with these terms and conditions.
- 4.2. Only one registration per eligible participant (and per email address supplied) will be accepted.
- 4.3. After registration, eligible participants may participate in all remaining races that have not already been completed or locked out.

5. TIPPING GAME

- 5.1. The participant must make one selection per race.
- 5.2. The participant may make or change a selection up to three minutes before the advertised start time of a race.
- 5.3. The participant will be allocated odds based points based on their selection and where it places.
- 5.4. The participant will receive a virtual \$20 per race (7 races), the participant will also receive a virtual \$50 for a big bet that you can use on your 'sure thing' (1 race).
- 5.5. The Entertainment Grounds Virtual Punters Challenge will use the final, official NSW tote (not fixed).
- 5.6. In the event of a selection being disqualified for any reason then the participant's selection for that race will receive zero points. In the event of a no-race, an abandoned meeting, or a cancelled meet the selections of eligible participants will receive zero points.
- 5.7. If the race meet cancelled before the conclusion of the 3rd race, the competition is null and void. If the meeting is cancelled after the 3rd race, the winner will be the individual in front at that time.
- 5.8. If there is a late scratching, the punters tip will revert to the favourite in that race.
- 5.9. If the participant:
 - 5.9.1. does not submit a selection for a given race then the participant's selection for that race will forfeit their bet;
 - 5.9.2. enters the promotion after the commencement of the first race then the participant will receive zero points for all missed races;
- 5.10. The participants will be ranked on a leader board displayed on television screens across the venue. These rankings are an indication of ranking for all participants in The Entertainment Grounds Virtual Punters Challenge, including persons who participate but are not eligible participants.

6. GENERAL

- 6.1. The promoter is the Gosford Race Club (ABN 26 003 846 124) of 4 Racecourse Road, Gosford NSW 2250.
- 6.2. By participating in The Entertainment Grounds Virtual Punters Challenge, the participants agree to being contacted by the promoter from time to time in conjunction The Entertainment Grounds Virtual Punters Challenge. Eligible participants also agree to information about them and their participation in The Entertainment Grounds Virtual Punters Challenge being displayed on the website and to their participation being tracked.
- 6.3. The promoter accepts no responsibility for any registrations not received for any reason during the promotion period. Registrations will be deemed to be accepted at the time of receipt and not at the time of transmission. No responsibility will be taken for lost, late or misdirected registrations. The promoter is not responsible for technical difficulties with the online registration process and does not warrant that the online registration will be available at all times.
- 6.4. If for any reason The Entertainment Grounds Virtual Punters Challenge is not capable of running as planned, due to infection by computer virus, bugs, tampering, unauthorised intervention, fraud, technical failures or any other causes beyond the control of the promoter, which corrupt or affect the administration, security, fairness, integrity or proper conduct of this promotion, the promoter reserves the right in its sole discretion to take any action that may be available, subject to compliance with any laws.
- 6.5. Any participant who, in the opinion of the promoter, tampers or interferes with the entry mechanism in any way, or who does not properly comply with the entry process, including submitting incomplete registrations, will be ineligible to participate.
- 6.6. The promoter reserves the right to disqualify participants in the event of non-compliance with these rules.
- 6.7. In the event there is a dispute concerning the conduct of The Entertainment Grounds Virtual Punters Challenge, the decision of the promoter is final and binding on each person who participates, and no correspondence will be entered into.
- 6.8. The promoter, the Great Tipoff and their associated agencies and companies shall not be liable for any loss or damage whatsoever (including but not limited to direct or consequential loss) or personal injury suffered or sustained in connection with The Entertainment Grounds Virtual Punters Challenge.
- 6.9. By participating in The Entertainment Grounds Virtual Punters Challenge, the participant agrees and acknowledges that:

- 6.9.1. they may be contacted by the promoter to provide comments The Entertainment Grounds Virtual Punters Challenge and the promoter (or an agent of the promoter) may take photos of them;
 - 6.9.2. the promoter may duplicate, alter, adapt and utilise the comments and photos as the promoter wishes at anytime, anywhere, and by any means. The promoter may license, authorise or otherwise transfer the rights in the comments and photos to others to do the same;
 - 6.9.3. and they agree not to institute, maintain or support any claim or proceeding for infringement of their moral rights in the comments and photos.
- 6.10. If any participant attempts to deliberately damage the website or the information on the website, or to otherwise undermine the legitimate operation of the game, the promoter reserves the right to take legal action permitted by law.

7. PRIZES

- 7.1. All winners will need to claim their prizes within 5 minutes of being contacted post the final leader board results being published. You will be contacted via the phone number in your registration and told where to collect your prize.
- 7.2. If a winning eligible participant is unable to accept a prize for whatever reason, the promoter will award that prize to the next eligible participant who meets the eligibility criteria and would have been deemed to be the winner had the winning eligible participant not participated in the promotion;
- 7.3. All winners will be notified on the day of the event (14th March 2020) by the promoter and their name will be published on the promoter's website.
- 7.4. To claim a prize, a winning participant must provide proof of identity, proof of age and proof of their normal residential address, the postcode of which must match the one nominated in their registration details.
- 7.5. If a winning eligible participant does not provide proof of identity, age and normal residential address to the promoter within five minutes of being contacted then the prize will be forfeited. If a winning eligible participant provides any incorrect or invalid contact details their entry is null and void. If the promoter is unable to contact a winning eligible participant or that participant does not make themselves known to the Club within five minutes of the final leader board results, then the prize will be forfeited, and the next highest ranked eligible participant will be deemed the winning eligible participant.
- 7.6. In the unlikely event of a tie, the winner will be determined by the single largest return. If this is also the same, then a continued count back will occur until the largest non-duplicate return is found.

- 7.7. Prizes will be awarded to the eligible participants with the three highest overall scores at the end of the 14th March 2020, within 5 minutes of the final leader board results:
 - 7.7.1. First prize 10 people in the Triton Lounge at the Eels V Tigers game on Monday 13 April + \$500 hospitality & beverage gift card to use. RRP \$1,500
 - 7.7.2. Second prize ATC General Admission + Members Access on Saturday 11 April (The Championships Race Day) for 4 people RRP \$840
 - 7.7.3. Third prize Entry & Hospitality to Roosters V Manly on 21st March for 4 people RRP \$700
 - 7.7.4. The first THREE runner up participants will receive a double pass to Gold Rush Festival on Saturday 9 May at the Gosford Gold Cup Race Day RRP \$98
- 7.8. Total prize value is \$3,334 and it is correct as at Thursday 5 March 2020.
